

IDEA Part B Grants to States – NOFO Frequently Asked Questions

Fiscal Year 2027 Special Education Paraprofessional Professional Development

Who is eligible to apply?

Local Education Agencies (LEAs); institutions of higher learning; public university laboratory schools approved by the Illinois State Board of Education (P.A. 100-465); area vocational centers (P.A. 92-56); charter schools; cooperatives and other joint agreements with a governing body or board of control (e.g., special education cooperatives); nonprofit organizations and schools operated by a Regional Office of Education, Immediate Service Center (P.A. 87-1124), or state agency are eligible to apply. The State of Illinois Grant Accountability and Transparency Act require applicants to complete [pre-qualification requirements](#).

Who is eligible to apply?

Nonprofit organizations may apply, even if they are not part of a Regional Office of Education.

What is the review and selection process for applications?

ISBE is required to design and execute a merit-based review and selection process for competitive grant applications. This process is incorporated by reference in all applicable funding opportunities. Applicants are advised to refer to the [ISBE Merit-Based Review Policy](#).

What is the grant period and award for this competitive application?

The grant period will extend from the execution date of the grant until June 30, 2027, Successful applicants may reapply via continuing application for up to two additional year(s). One grant will be awarded in FY 2027 (Year 1 of the project) in an amount not to exceed \$300,000. It is the intention of ISBE to fund this project for three years (through FY 2029). The annual grant award in successive years of the grant period will be \$300,000 Funding in the subsequent years will be contingent upon compliance with federal and state law, state grant-making rules, passage of sufficient appropriations for the program, and satisfactory performance in the preceding grant period. No promise or undertaking made in this Notice of Funding Opportunity (NOFO) is an assurance that a grant agreement will be renewed, nor does this NOFO create any right to or expectation of renewal.

How may a proposal application be submitted to ISBE?

Electronic submission: Completed proposals should be submitted electronically no later than 5 PM July 20, 2026, to Deb Scott, descott@isbe.net

Will late proposal submissions be accepted?

No, late proposals will not be accepted for ISBE review.

When will the grant award be announced?

It is anticipated that successful applicants will receive a Notice of Award via email approximately 90 days after the application deadline. The award letter is NOT an authorization to begin performance or expenditures. After the merit-based appeal timeframe has ended, awardees will receive additional information from the program area that includes the next steps for finalizing the grant.
